### **Invitation**

The exact schedule of the conference can be found in the enclosed program. In exceptional cases, we reserve the right to change speakers and make other content-related and organizational changes.

### **Participation fee and services included**

The participation fee per participant is EUR 1390.00 plus VAT. The welcome bonus of 990 euros plus VAT applies to first-time participation in the EE-Kolleg.

The fee includes accommodation with half board, drinks and snacks during breaks, possible participation in accompanying events and transfer from the airport to the hotel. Also included is a flight up to a price limit of 370 euros from one of the possible airports to Mallorca and back, or a flat rate of 370.00 euros for booking a flight via the partner company of the organizers ASYS Automatisierungssysteme GmbH. Additional flight costs will be charged over and above the participation fee. You will receive your travel documents in good time before departure.

### **Payment**

After receipt of your registration you will receive a confirmation of registration via ASYS Group as well as the invoice for the participation fee on behalf of the organizers. The participation fee is due immediately and without deduction upon receipt of the invoice. Your participation in the seminar can only be guaranteed if payment of the participation fee has been received before the start of the event.

### **Withdrawal**

If you cancel your registration or fail to attend, the full fee will be charged. It is of course also possible to substitute the registered participant, but rebooking costs will be charged. Name changes are not possible for flights. Cancellations must always be submitted in writing.

### **Disclaimer**
